- Providing emotional and practical support
- Co-creating, and supporting, community development initiatives with tenants
- Facilitating life-skills development
- Intervening in, and de-escalating, crises and conflicts
- Providing referral to, and collaborating with, appropriate health and community social services
- Participating in evaluation, planning, group meetings and supervision
- Addressing breaches of the lease agreement and the Residential Tenancies Act, and appearing at the Ontario Landlord and Tenant Board as required.
